1. Click on the blue link in the email you received from Beasley Allen. This will bring you to a website to record your video.

To Record Your Video

1. We have created a website to help get the process started. If you are on an iPhone or iPad, [click here](#). If you are on a computer that has a camera, [click here](#).
2. Or, you can type www.truthabouttalc.com/injustice into your internet browser. The most common browsers are Safari (iPhone and iPad) and Chrome (Android).
3. Make sure your device is connected to the internet/Wi-Fi because the video will be uploaded to the website after you're done recording.
4. The red button is used to start and end your recording.
5. If you need help, recruit a tech-savvy friend or family member.
6. If you run into issues, you can call XXX-XXX-XXXX and someone at the firm will try to assist you.

We will return your edited video to you with suggestions for sharing it on other social media platforms such as Facebook and Instagram.


Click the red ‘create a video’ button and tell us: What’s your reaction to J&J’s efforts to escape responsibility by filing bankruptcy?




Video Tips


3. The screen may ask you to “allow” access to your microphone and camera - click “Allow”.




4. Click the big red button to start recording.


